2. Vendor agrees to be responsible for its own affairs and property and that the Armonk Lions Club is not responsible for any loss suffered by the Vendor. Security against loss is not guaranteed.
3. Vendors are responsible for collection and remittance of sales tax and for compliance with all applicable state and local laws and regulations.
4. This contract may be terminated by the Armonk Lions Club for **sale by Vendor** of:
 - a. Any items of merchandise not specified in "Type of Merchandise".
 - b. Beverages of any kind (Alcoholic or otherwise).
 - c. Fireworks or any illegal substance.
 - d. Raffles or other gambling-related items.
 - e. Violent or Sexually Orientated Material.
5. Vendor fees are non-refundable.
6. Vendors are responsible to provide their own tents and tables.
7. All Vendor vehicles must be removed from the vendor area by 10:30 a.m. Saturday.
8. Vehicles are not permitted in vendor area during hours of operation; parking near vendor spots is not permitted.
