**Food Vendor Rules, terms and conditions that Food Vendors are agreeing to:**

THE FOLLOWING WILL BE STRICTLY ENFORCED:

1. To the fullest extent permitted by law, the Food Vendor shall indemnify and hold harmless the Armonk Lions Club, Inc. and its respective officers, directors, members, volunteers, employees, contractors, agents, and representatives, for any and all claim(s) for damages, loss, costs or any expenditures arising out of or relating to the Food Vendor's activities at the Festival.
2. Food Vendor agrees to be responsible for its own affairs and property, and to the fullest extent permitted by law releases, the Armonk Lions Club, Inc. and its respective officers, directors, members, volunteers, employees, contractors, agents, and representatives, from any and all loss or liability suffered by the Vendor. Security against possible loss is not guaranteed.
3. Food vendors are responsible for collection and remittance of sales tax and for compliance with all applicable state and local laws and regulations, including, without limitation, Westchester County Department of Health food permit.
4. This contract may be terminated by the Armonk Lions Club, Inc. in its sole discretion, for any reason or without cause, or for **sale by Food Vendor of:**
  - a. any items of food not specified in "menu of food to be sold"
  - b. any beverages of any kind (alcoholic or otherwise) not specified in "menu of beverages to be sold"
  - c. Fireworks or any illegal substance
  - d. Raffles or other gambling-related items
  - e. Violent or Sexually Oriented material
5. Food Vendor fees are non-refundable.
6. **All Food Vendors must be on site and open for all Festival Dates and Times.** Vehicles, besides Food Trucks, must be removed from the fairgrounds by one hour prior to the start time, each day.
7. **All food and beverage prices must be posted.**

This Contract must be signed by the Food Vendor and returned to the Armonk Lions Club, Inc. with payment. The Food Vendor agrees that payment shall be provided to the Armonk Lions Club, Inc. as follows: 50% Deposit due with submission of contract, remainder 50% due no later than April 30<sup>th</sup>.

Checks are made **payable to the Armonk Lions Club, Inc.** at P.O. Box 211, Armonk, New York, 10504. An additional 3.7% credit card fee will be charged. You must mail your original signed contract to our P.O. Box even if payment is by credit card.
