Vendor Rules, terms and conditions that Vendors are agreeing to:

THE FOLLOWING WILL BE STRICTLY ENFORCED:

1. Vendor fees are non-refundable.
2. Vendors are responsible to provide their own tents and tables.
3. To the fullest extent permitted by law, the Vendor shall indemnify and hold harmless the Armonk Lions Club, Inc. and its officers, directors, members, volunteers, employees, contractors, agents, and representatives, for any and all claim(s) for damages, loss, costs or any expenditures arising out of or relating to the Vendor's activities at the Festival.
4. Vendor agrees to be responsible for its own affairs and property and to the fullest extent permitted by law, releases the Armonk Lions Club, Inc. and its officers, directors, members, volunteers, employees, contractors, agents, and representatives, from any and all loss or liability suffered by the Vendor. Security against possible loss is not guaranteed.
5. Vendors are responsible for collection and remittance of sales tax and for compliance with all applicable state and local laws and regulations.
6. This contract may be terminated by the Armonk Lions Club, Inc. in its sole discretion, for any reason or without cause, or for **sale by Vendor** of:
 - a. Any items of merchandise not specified in "Type of Merchandise".
 - b. Beverages of any kind (alcoholic or otherwise).
 - c. Fireworks or any illegal substance.
 - d. Raffles or other gambling-related items.
 - e. Violent or Sexually Oriented material.
7. All Vendor vehicles must be removed from the vendor area by 10:30 a.m. Saturday.
8. Vehicles are not permitted in the vendor area during hours of operation; parking near vendor spots is not permitted.
9. Vendors who sign up for Side A that do not participate on Friday night will automatically be placed on Side B on Saturday.
